Textbook requests that do not have the above information will not be filled.

Students may not write, highlight or in any other way damage the textbooks, unless of course they are of a consumable nature, which will be noted when the books are given to the parent. If there is excessive damage to a book, parents will be charged a fee to restore or replace the book.
